Overview of the International Conference on Cohesive Societies 2025

Our increasingly complex world faces new challenges to cohesion, from shifting identities to rising uncertainties and deepening societal divides. Against this backdrop, ICCS 2025 will explore how multiculturalism, resilience, and dialogue can serve as foundations for harmony in diversity.

The ICCS 2025 conference is built around three thematic pillars — Unpacking Multiculturalism, Navigating Uncertainty, and Forging Societal Resilience — and features a series of plenaries, breakout discussions, and skills workshops. The plenaries will bring together leading thinkers and practitioners to reflect on the evolving dynamics of cohesion, while the breakout sessions will delve deeper into specific issues facing multicultural societies today.

New to ICCS 2025, skills workshops will equip participants with practical toolkits in areas such as futures skills, conflict resolution, and humanitarian action. The Showcase session will highlight real-world examples of how communities are igniting change at the grassroots level. Sharing sessions will also provide opportunities for delegates to discuss best practices and common challenges.

Youth voices will also take centerstage through a special youth-led plenary: “Cohesion Forward” and a dedicated Young Leaders Programme, underscoring the critical role of the next generation in forging resilient, inclusive societies.

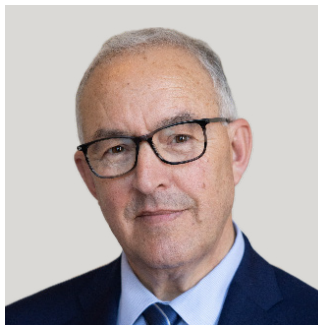

By engaging with local communities and exploring Singapore's diverse neighborhoods, delegates will gain invaluable insights into how social cohesion is fostered and how diverse faith and cultural practices enrich life in a vibrant, multicultural society.

Community Exploration 2025 will be held in the evenings of 24 and 25 June 2025 after the day's proceedings, with four concurrent sessions per day.

Programme Overview

Day 1

Sri Mariamman Temple and Masjid Jamae Chulia

This segment of the journey will explore two of Singapore's oldest religious landmarks, located in the heart of Chinatown. At Sri Mariamman Temple, Singapore's oldest Hindu temple, visitors will witness the Dravidian architecture and participate in understanding Hindu rituals and traditions. Just a short walk away, Masjid Jamae Chulia, one of the earliest mosques in Singapore, offers a contrast with its Islamic architecture and history of the Muslim community in Singapore.

Singapore Chinese Cultural Centre

At the Singapore Chinese Cultural Centre, the learning journey will uncover the unique Chinese Singaporean culture. Participants will engage with exhibitions that reveal the traditions, practices, and contributions of the Chinese community in Singapore. The centre's programs and activities aim to foster greater appreciation of the Chinese arts and culture that have shaped the nation's multicultural tapestry.

Our Tampines Hub

Our Tampines Hub is a vibrant community and lifestyle destination that reflects the heartland's spirit. The learning journey here will cover the various facilities and initiatives that promote multiculturalism and community bonding. Visitors will experience how the hub serves as a model for future community spaces in fostering social harmony and inclusivity.

Kampong Gelam Heritage District

Kampong Gelam Heritage District is a historical gem that stands as a testament to Singapore's Malay heritage and its early Islamic history. The learning journey through this vibrant district will immerse visitors in the rich tapestry of Malay culture, arts, and traditions. This visit to Kampong Gelam will highlight the importance of preserving cultural heritage while embracing modernity, and how it contributes to the multicultural landscape of Singapore.

Day 2

National Gallery Singapore

National Gallery Singapore is a treasure trove of Southeast Asian art, housed in two national monuments. The learning journey here will cover the world's largest public collection of Singaporean and Southeast Asian art, spanning the 19th century to present day. Visitors will gain an understanding of the region's rich cultural heritage through the visual arts, and how it has evolved over time.

Indian Heritage Centre

The Indian Heritage Centre offers a deep dive into the rich history and culture of the Indian community in Singapore. Visitors will explore four floors of interactive exhibits, showcasing artifacts and stories from the diaspora's past to the present. The journey will cover the contributions of the Indian community to Singapore's nation-building and provide insights into traditional Indian arts, such as dance and music.

One Punggol

One Punggol is set to be a landmark for community engagement and integration. The learning journey will showcase how this development brings together residents of different backgrounds through its integrated community and lifestyle facilities. Participants will learn about the innovative approaches to community building and the promotion of a kampung spirit in a modern setting.

Community Law Centre @ Tian De Temple

The Community Law Centre at Tian De Temple represents a unique blend of legal aid within a religious institution. Visitors will learn about the temple's history and its role in the community, as well as how the law centre provides accessible legal services and promotes understanding of legal rights among residents. This visit will highlight the collaboration between religious organizations and social services to support the community.

Young Leaders Programme



Organised in conjunction with the ICCS, the Young Leaders Programme (YLP) is a dynamic platform for the emerging local and international leaders to network, ideate and collaborate on initiatives that strengthen social cohesion. The YLP connects young leaders from Southeast Asia and beyond, fostering a vibrant community where ideas are shared, skills are honed, and confidence is built to address social cohesion challenges. YLP harnesses the energy and creativity of youth to drive practical solutions and contribute meaningfully to building a more cohesive and resilient society.

YLP 2025 will focus on experiential and interactive learning sessions where youths across the world get to exchange unique cultures, share fresh perspectives, and ideate innovative approaches to foster cohesion and harmony. Through working with select youth alumni as part of the YLP 2025 Working Committee and involving YLP delegates as co-creators of the programme, we also support youth leadership and their development.

YLP Forum Theatre Experience

To encourage insightful participation and reflections, YLP delegates will go through a forum theatre experience, an interactive theatre that allows audience to participate in the performance by suggesting changes in the action or even stepping in as actors to alter the course of the story. Delegates will be engaged in post-forum theatre reflections facilitated via a civic conversation toolkit.

YLP Breakout Sessions

1. Volunteer Quest: Expedition of Harmony

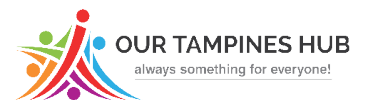

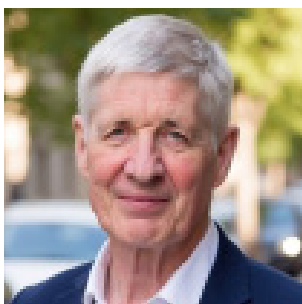
Catherine Fieschi is a leading European politics expert and global analyst. Her main focus is on the rise of populist and authoritarian politics in advanced democracies and the social and political pressures such politics inflict on diverse societies. She is a longstanding adviser to progressive political leaders and campaigns across the globe.

A Senior Fellow at the Robert Schuman Centre of the European University in Florence, Europe's foremost policy and research institute, Catherine is also a Senior Advisor to the London-based geo-political advisory firm, Macro Advisory Partners.

The founder of Counterpoint, a UK-based think tank that provided governments, businesses, and NGOs around the world with strategic insights on how to manage new forms of social and political risk, she served as its Executive Director until April 2023. Previously, she served as director of the UK's leading think tank Demos, and as Director of Research at the British Council. Widely published in academia and beyond, Catherine is a regular political and social commentator (FT, The Guardian, Politico, BBC, CNN, etc). She is the author of, most recently, *Populocracy: The Tyranny of Authenticity and the Rise of Populism* (2019); and is currently writing a book on women and the far right.

Catherine is a member of the OECD's Expert Group on Foresight and is on the International Board of the National Centre for Social Research in the UK.

A native speaker of French, Italian and English, Catherine holds a PhD in Comparative Politics from McGill University in Canada and lives in Paris.

Mike Hardy is Professor of Intercultural Relations and founding Director of the Centre for Peace and Security at Coventry University and adjunct Professor of Leadership at ICB LSRP Indonesia. He is Board Chair of the International Leadership Association, (www.ilaglobalnetwork.org) and a member of the International Advisory Board of ICESCO. His recent passion has been the development of Coventry's **Public Leadership Lab**, an innovation and experience-sharing process pointed at positive peacebuilding. His current work is based on extended conversations with global influencers: *Leading and Learning in a Polycrisis World*.

Mike trained as economist, and was a Fulbright Scholar in California before leading Economics Departments at both Leeds and Lancashire Universities in the UK.

From 1995-2011, Mike was a UK diplomat posted in Cairo, Ramallah and Jakarta. Honoured in 2001, awarded the OBE for his peace-building work in the Middle East, and appointed a UK Companion of Honour of St Michael and St George (CMG) in 2010 for his work globally in Intercultural Dialogue. In 2002, he was recognised by the United Nations for work with civil society in the Levant, and in 2024 by the Government of Indonesia, PIN EMAS, for his support to the development of Indonesia's Counter Terrorism Strategy.

Aaron's work at the Blavatnik School focuses on issues connecting technology, public policy and public administration. He co-chairs the World Economic Forum's Global Future Council on the Future of Technology Policy and is a member of the OECD's Expert Group on Artificial Intelligence (AI) Futures.

Previously a policymaker in the Singapore government, he was most recently Deputy Secretary (Industry & International) at the Singapore Ministry of Communications & Information, overseeing the ministry's work in the digital economy, digital literacy and inclusion, and digital diplomacy - with a concurrent cross-government role coordinating Singapore's strategy in global branding, soft power and public diplomacy. Before that, he served in the Ministries of Foreign Affairs and Trade & Industry, the Public Service Division and Civil Service College. In particular, he was the founding Head of the Centre for Strategic Futures, currently under the Prime Minister's Office Strategy Group, and Institute Director for the Institute of Public Sector Leadership. In both roles, he was involved in conceptualising, facilitating, delivering and sustaining cross-government strategy, visioning, leadership development and organisational development efforts, as well as sharing Singapore's work with other countries in capability-building programmes.

He was recognised by the World Economic Forum as a Young Global Leader in 2013, by the Asia Society as an Asia 21 Young Leader in 2007, and is a Fellow of the Royal Society for the encouragement of the Arts, Manufacture and Commerce (FRSA).

In New Zealand she has provided consultancy and advice to various government ministries and NGOs on these issues and is currently leading a project on multiculturalism and indigeneity funded by a Royal Society Marsden grant. Professor Ward has also served as President of the International Association for Cross-cultural Psychology, the International Academy for Intercultural Research and the Asian Association of Social Psychology. In addition, she was Editor-in-Chief of the International Journal of Intercultural Relations.

He also serves as Chairman of the Social Science Research Council (SSRC), Chairman of the Campus for Research Excellence and Technological Enterprise (CREATE) Governing Council, Chairman of the Office for Space Technology & Industry (OSTIn) Board, Chairman of PRECision Health Research, Singapore (PRECISE) Board Oversight Committee, Chairman of the National Gallery Singapore (NGS), and Chairman of the Institute for Intelligent Functional Materials (I-FIM) Governing Board. He is also a member of the Board of Governors of the S Rajaratnam School of International Studies (RSIS), and of the Lee Kuan Yew School of Public Policy (LKYSPP).

When he retired from the Singapore Administrative Service in 2010 after a career in the Public Service stretching more than 34 years, he was Head, Civil Service, concurrent with his other appointments of Permanent Secretary (Foreign Affairs), Permanent Secretary (National Security & Intelligence Coordination), and Permanent Secretary (Special Duties) in the Prime Minister's Office. Before that, he was Permanent Secretary (Defence). He was also the inaugural Chairman of the Maritime and Port Authority of Singapore.



Mr Ahmed Aboutaleb

Over the years, Ahmed Aboutaleb has established himself as a dedicated public servant who strives to create a city — and a society — where everyone can thrive regardless of their background. His tenure in Rotterdam has been marked by firm yet empathetic leadership: he is known for promoting social cohesion and encouraging dialogue between diverse groups.

Born in Beni Sidel, in the Moroccan province of Nador, he moved to the Netherlands at the age of sixteen. He settled in The Hague, where he continued his education and earned an engineering degree in electrical engineering with a specialisation in telecommunications. Following his studies, he embarked on a career in journalism, working with renowned Dutch media outlets such as NOS and RTL. This period provided him with invaluable insights into Dutch society's complexities and laid the groundwork for his future in public service.

In the early 2000s, Aboutaleb decided to step into public service. He joined the Labour Party (PvdA) and served as an alderman in the city of Amsterdam from 2004 to 2007, focusing on issues like education and youth policy. Recognized for his ability to bridge cultural divides, he was appointed State Secretary for Social Affairs and Employment in the fourth Balkenende cabinet in 2007. During this time, he worked on policies to improve the social integration and economic participation of marginalised communities.

In 2009, Aboutaleb made history as the first mayor of a major European city with a Moroccan immigrant background. His leadership in Rotterdam has brought him widespread national and international acclaim. In 2021, he was honored with the title of "Best Mayor in the World". Shortly before stepping down, he was appointed Commander of the Order of Orange-Nassau and received the prestigious Johan van Oldenbarnevelt Medal, celebrating his unwavering dedication to the city and its residents.

Ahmed Aboutaleb is a highly regarded and internationally respected leader, distinguished by his decisive and inclusive approach to governance. His ability to unite diverse communities and tackle complex challenges with empathy and foresight has firmly established him as one of the world's most respected and influential leaders.

He served as the President and CEO of ICANN from 2012 to 2016, the international body governing the Internet's key resources and policies. Additionally, Fadi was senior advisor to Klaus Schwab, the Executive Chairman of the World Economic Forum, and a member of the UN Secretary-General's High-Level Panel on Digital Cooperation. Recently, Carnegie Corporation of New York honored Fadi as a 2020 Great Immigrant.

Kumar Ramakrishna is Professor of National Security Studies, Provost's Chair in National Security Studies, Dean of the S. Rajaratnam School of International Studies (RSIS), as well as Research Adviser to the International Centre for Political Violence and Terrorism Research, at RSIS. Prior to his current appointments, he was Head, International Centre for Political Violence and Terrorism Research (2020-2022), Head, Centre of Excellence for National Security (2006-2015) and Head, National Security Studies Programme (2016 to 2020). He was also Associate Dean for Policy Studies (2020 to 2022).

A historian by background, Professor Ramakrishna has been a frequent speaker on counter-terrorism before local and international audiences, a regular media commentator on counter-terrorism, and an established author in numerous internationally refereed journals. His first book, *Emergency Propaganda: The Winning of Malayan Hearts and Minds 1948-1958* (2002) was described by the *International History Review* as "required reading for historians of Malaya, and for those whose task is to counter insurgents, guerrillas, and terrorists". His second major book, *Radical Pathways: Understanding Muslim Radicalisation in Indonesia* (2009) was featured as one of the top 150 books on terrorism and counterterrorism in the respected journal *Perspectives on Terrorism*, which identified Professor Ramakrishna as "one of Southeast Asia's leading counterterrorism experts". His recent research has focused on understanding, preventing and countering violent extremism in Southeast Asia. His latest book is *Extremist Islam: Recognition and Response in Southeast Asia* (New York: Oxford University Press, 2022).

These include the School Advisory Committee, the Advisory Council on Community Relations in Defence (ACCORD), the executive committee of SINDA, and the Hindu Advisory Board.

He earned his PhD from Utrecht University (2005), MPhil from the International Institute for the Study of Islam in the Modern World (2000), and MA from Leiden University (1999), all with cum laude distinctions. Following his PhD, he enriched his academic experience through postdoctoral and research fellowships at the National University of Singapore, KITLV Leiden, Nanyang Technological University, and Clingendael Den Haag. 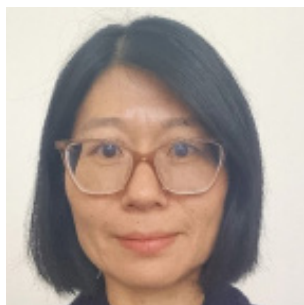

She also co-founded the Ana Frank Argentina Center for Latin America.

As an activist for human rights and social justice, she is the author of various books on education, human rights, and interreligious coexistence. For her excellent work in advocating for equal opportunities, as well as social and religious coexistence against any discrimination, she has been declared a Distinguished Personality by the city of Buenos Aires.

She is concurrently a board member of the G20 Forum of Religions, (R20), a member of the Advisory Council of the Center for Shared Civilizational Values, as well as the Permanent Secretariat of the G20 Religion Forum (R20). Apart from these, she is also a member of the Advisory Board of the Milstein Center for Interreligious Dialogue at the Jewish Theological Seminar (JTS) and part of the executive committee of Global Jewry, a global platform for Jews worldwide.

Rabbi Chemen co-authored the seminal document, Abrahamic Faiths Initiative: An Invitation to Conversation and Action, in collaboration with a small group of Christian and Muslim leaders — including key figures within the G20 Religion Forum (R20) — and the U.S. Department of State's Office of International Religious Freedom. Finally, she also works closely with senior Nahdlatul Ulama, CSCV, and R20 leaders in executing The Road Not Yet Taken Initiative: A Multi-Religious Path Towards Middle East Peace.

His recent passion has been the development of Coventry's **Public Leadership Lab**, an innovation and experience-sharing process pointed at positive peacebuilding. His current work is based on extended conversations with global influencers: Leading and Learning in a **Polycrisis** World.

Mike trained as economist, and was a Fulbright Scholar in California before leading Economics Departments at both Leeds and Lancashire Universities in the UK.

From 1995-2011, Mike was a UK diplomat posted in Cairo, Ramallah and Jakarta. Honoured in 2001, awarded the OBE for his peace-building work in the Middle East, and appointed a UK Companion of Honour of St Michael and St George (CMG) in 2010 for his work globally in Intercultural Dialogue. In 2002, he was recognised by the United Nations for work with civil society in the Levant, and in 2024 by the Government of Indonesia, PIN EMAS, for his support to the development of Indonesia's Counter Terrorism Strategy.

Katy is on the Editorial Board for *Geography Compass* and *Emotion, Space and Society*.
